**HadePlatform.com (HADE Platform) (the Site) (the HADE Platform) is a wholly owned subsidiary of HADE Technologies, LLC. By using HadePlatform.com you not only agree to its terms of use, but also the disclosure policy and privacy policy of HADE Technologies, LLC found at BNL Finance.**

**PLEASE READ THE FOLLOWING TERMS OF USE (“TERMS OF USE”) BEFORE ACCESSING OR USING HADEPLATFORM.COM AND/OR ANY RELATED SERVICES, FEATURES, PRODUCTS, EXTENSIONS, OR OFFERS OF HADEPLATFORM.COM (COLLECTIVELY, THE “SITE”). ## **SUBSCRIPTIONS; CHARGES ON YOUR BILLING ACCOUNT**

HADE Platform bills you for premium access to MatriX through your online account (your "Billing Account") for subscribing to the Site. You agree to pay HADE Platform all charges at the prices you agreed to for subscribing to the Site by using your Billing Account, and you authorize HADE Platform to charge your payment provider (your "Payment Method") for subscribing to the Site. You agree to make payment using that selected Payment Method.

Your subscription will continue indefinitely until cancelled by you in the "MatriX" area of HADE Platform. You can make changes to your subscription in the "MatriX" area. All services paid for with HPAY Token, an ERC-20 digital currency, are as is with no renewal option. My sending HPAY Token to our wallet address with or without using Hade Pay, you confirm the intention to purchase our service, identified by you before and after the purchase process. If you do not wish for your subscription to automatically renew or if you wish to cancel your subscription, you may do so at any time from the account services page. **Account Names and Private Keys.** When you create an Account and are approved to use Hade Pay or purchase HPAY Tokens, the Services generate and store a cryptographic private and public key pair that you may use to send and receive HPAY Tokens via Hade Pay or from any participating third party crypto exchanges. The Private Key uniquely matches the Account Name and must be used in connection with the Account Name to authorize the transfer of HPAY Tokens from that Account. You are solely responsible for maintaining the security of your Private Key and any password phrase associated with your wallet. You must keep your Account, password phrase and Private Key access information secure. Failure to do so may result in the loss of control of HPAY Tokens associated with the Wallet.

**No Password Retrieval.** HADE Platform does not receive or store your Account password, nor the unencrypted keys and addresses. Therefore, we cannot assist you with Account password retrieval for HPAY Token or to use Hade Pay. Our Services provide you with tools to help you remember or recover your password, including by allowing you to set password hints, but the Services cannot generate a new password for your Account. You are solely responsible for remembering your Account password. If you have not safely stored a backup of any Account Names and password pairs maintained in your Account, you accept and acknowledge that any HPAY Tokens you have associated with such Account will become inaccessible if you do not have your Account password.
